Taking the nation-state as the embodiment of modernity, this course looks at the ways the major economic changes of the last thirty years – globalisation, migration and slowing productivity growth in the West – are producing new forms of governance. Using a model of imperial blowback derived from the study of the trajectories of past empires, and in particular the Roman Empire, it will explore the idea that what the contemporary West is undergoing is a crisis of imperial decline. It will then discuss whether emergent forms of informal governance can be situated within the context of the changing social, political and economic landscape resulting from such a transition.
